## 1. About Fête and this Privacy Policy

Fête Games, Inc. (“Fête”) values your trust, so we want to tell you about the personal information we collect from you when you use our websites, how we use it, and who we share it with. That’s why we’ve created this privacy policy to keep you informed.

## 2. Definitions

For the purposes of our services, the definitions are as follows:

“**Personal Information**” means any information relating to a natural person who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, or an online identifier.

“**Privacy Policy**” or “**Policy**” means this Fête Games Privacy Policy.

“**Processing**” means any operation which is performed on Personal Information, such as collection, recording, organization, structuring, storage, adaptation or any kind of disclosure or other use.

Any other capitalized term that is not defined in this Policy is defined and has the meaning set out in our Terms of Use.

## 3. Information You Provide when Setting Up an Account on Fête

Everyone on Fête has to create an account in order to participate in our Experiences.

When you create a Fête account, we will ask you to choose a unique username and password (so that you can log into your account).

We will also ask you for your email address and date of birth.

If you become a Host, Co-host, Emcee, or a Business on the Platform, we may also ask for your name, physical address, phone number, website url, personal biography, profile photo, primary business contact, and social media account identifying information.

You should not create a username that includes your real name. It is also important to create a password that is not easy to guess. Never share your password.

## 4. Additional Personal Information We Collect When You Use Fête Features

You don't have to share any additional personal information with us (other than the information described above) to use our websites. We may collect other personal information when you use our platform, for example, if you pay to join an Experience, we will collect additional information in order to take the payment such as your name, billing address, email address and payment card details or other payment information.

If you contact us, for example, about a problem with our services, we may collect your contact information, such as your email address and other important information about your issue or concern. We will only use this information to solve your problem/concerns and to be able to reply to you.

When you browse and use our websites, we might collect information about your actions on the website to make your experience better. For example, we might look at your search history and suggest other Experiences that are similar.

We might also collect information from your device when you visit our websites, as outlined in the "Cookies and Similar Technologies" section.

Any information that you give to us or that we collect might be used to:

- keep the website running and to improve it;
- give you access to the website and additional features, or to restrict your access;
- make the content on the website personalized to you and make it easier for you to use;
- help you look after your Fête account, like changing your account settings;
- detect security incidents and protect against bad or illegal activity, and find those responsible for that activity; and
- protect your safety.

## 5. Cookies and Similar Technologies

We use tracking technology (such as "**Cookies**") on our websites to help us understand and improve our service, as well as to understand your preferences. A Cookie allows us to remember your actions and preferences on the website (such as your login details, your language settings and your font size preference) over a period of time so you don't have to re-enter them whenever you come back to the website or browse from one page to another. We will also remember your favorite Experiences and friends.

## 6. Information Sharing

Fête doesn't sell your information to other companies for them to use as they want.

Fête does have relationships with some companies that help us provide our services, so we may provide some of your information to them, but only because we need to in order to complete your transaction.

We also hire other people and companies to perform services for us. The other companies are only allowed to use the personal information we share with them to complete tasks that we hire them to do. They are not allowed to sell your personal information or use it for their own purposes.

### *Public forums and community areas*

There are some areas on Fête where you can communicate with other Fête users. These are public places and anything you share in these areas is available to other Fête users who can access the same places. You should remember this before you post any information in these public areas.

### *Hosts*

We may share your username, avatar, city, state and country, social media links, and your list of Experiences with the Hosts of the Experiences you access, as well as any other Users you may "Friend" on the Platform.

## 7. Security and Data Retention

The security of your information is important to us. We have measures in place to protect it against loss, misuse, or tampering. However, no security measures are 100% effective, so we cannot guarantee against these risks.

We will only keep your information for as long as we need to in order to effectively provide the Services to you and other Users.

## 8. External Links

Sometimes you may find a link to another company's website on our website or app. We aren't responsible for that company's privacy policies or content. If you are being directed to another site, we may display a warning message to give you a heads up.

## 9. Accessing and Updating Your Personal Information

## 10. Privacy of Your Personal Information
